RESEARCH

Thesis: “The Sarbanes-Oxley Act and Small Public Companies”

I examine the costs and benefits of the Sarbanes-Oxley Act (SOX) of 2002 on small public companies. I present a comprehensive measure of Section 404 costs by developing models of direct and indirect costs based on financial statement information. In this research I also found that earnings quality of all filers increased as a result of SOX regardless of size. Furthermore, I find that informativeness of earnings and financial statement filing increased as a result of the acceleration of reporting dates and Section 404 compliance.
